**ON ENTERING OF PROHIBITION FROM CROSSING THE STATE BORDER INTO
IDENTITY CARD FORM OF BOSNIA AND HERZEGOVINA NATIONALS
(Official gazette 39/02)**

Pursuant to Article 40, paragraph (2) of the Law on identity cards of BiH nationals (Official Gazette of BiH, No.32/01) and the Law on amendments to the Law on identity cards of BiH nationals (Official Gazette of BiH, No.16/02) the Ministry of Civil Affairs and Communications of Bosnia and Herzegovina has passed a

RULEBOOK

ON ENTERING OF PROHIBITION FROM CROSSING THE STATE BORDER INTO IDENTITY CARD FORM OF BOSNIA AND HERZEGOVINA NATIONALS

Article 1

This Rulebook shall stipulate means of entering of prohibition which specifies that identity card shall be prohibited to be used for crossing the State Border to the ID card holder in accordance with the Decision of the competent court or other body responsible for issuing travel documents.

Article 2

If a competent court or body prohibits issuing of a travel document to a BiH national, the competent authority for issuing ID cards referred to in Article 7 of the Law on Identity Card of Bosnia and Herzegovina Nationals shall endorse a Decision on prohibition of use of the ID card for crossing the State Border to an individual to whom an ID card has been issued or who has submitted an application for issuance /replacement of ID card.

Article 3

Following the adoption of the Decision on prohibition from crossing the State Border, a competent authority referred to in the preceding Article shall notify the ID card holder to bring the ID card immediately upon receipt of notification for the purpose of entering of the prohibition from crossing the State Border.

Article 4

Entering of prohibition from crossing the State Border shall be carried out so that upon storing of a valid ID card, a new ID card is issued to that person and the following text entered into the column "Notes:" on the back of the ID card form: "Prohibited to cross the State Border".

Entering of prohibition from crossing the State Border to an individual applying for issuance/replacement of ID card shall be carried out during the procedure for issuance/replacement of ID card.

Article 5

A competent authority shall, upon expiry of reasons for prohibition from crossing the State Border, notify the ID holder referred to in the preceding Article for the purpose of annulment of the ID card with the prohibition from crossing the State Border, i.e. for the purpose of return of previously deposited ID card.

The ID card with the prohibition shall be annulled.

Article 6

Any charges for entering of prohibition from crossing the State Border into the ID card form shall be stipulated by a special act.

Article 7

This Rulebook shall enter into force as of the date of its publication in "Official Gazette of BiH".

This Rulebook shall be published in the official gazettes of the entities and Brčko District of BiH.
