Pursuant to Article 33 of the Law on Travel Documents of Bosnia and Herzegovina (Official Gazette of BiH ", Nos. 4/97, 1/99, 9/99, 27/00, 32/00, 19/01, 47/04, 53/07, 15/08, 33/08 and 39/08), the Ministry of Civil Affairs of Bosnia and Herzegovina issues a

RULEBOOK ON SUPERVISION OVER THE ENFORCEMENT OF THE LAW ON TRAVEL DOCUMENTS OF BOSNIA AND HERZEGOVINA

Article 1

(Subject)

This Rulebook shall stipulate the manner of supervision over the enforcement of the Law on Travel Documents of Bosnia and Herzegovina.

Article 2

(Competent supervising bodies)

(1) Supervision over the enforcement of this Law shall be carried out by the Ministry of Civil Affairs of Bosnia and Herzegovina, the authorities responsible for issuing of travel documents in the entities and Brčko District as provided for by this Rulebook.

(2) Supervision referred to in paragraph (1) of this Article which is under the responsibility of the Ministry of Civil Affairs of Bosnia and Herzegovina is carried out by persons authorized in writing by the Minister of the Ministry of Civil Affairs of Bosnia and Herzegovina, and in the Entities and Brčko District, by a person authorized in writing by the executives of the authorities responsible for issuance of travel documents.

Article 3

(Rights and duties of persons during supervision)

Persons referred to in Article 2 of this Rulebook shall have the right and obligation to supervise all the bodies in Bosnia and Herzegovina, entities and Brčko District if: a body has issued the travel documents as prescribed; if a travel document has been issued by the competent authority; if a travel document has been issued subject to the prescribed procedure; if records of issued travel documents have been properly maintained; if the files have been archived according to the Law on Archives; and they also have the right to control the implementation of other provisions of the above Law.

Article 4

(Submission of supervision reports)

Persons authorized to carry out supervision shall provide responsible persons who manages the authorities referred to in Article 2 of this Rulebook with a Supervision Report, if necessary, inform in writing those responsible persons about the observations acquired during the supervision.

Article 5

(Superseding of previous regulations)

By entry into force of this Rulebook, a Rulebook on Supervision over the Law on Travel Documents of Bosnia and Herzegovina (Official Gazette of BiH, no. 10/98) shall cease to be effective.

Article 6

(Entry into force)

This Regulation shall enter into force on the eight day following the day of publication in the Official Gazette.
