
**RULEBOOK ON
FEES OF TRAVEL DOCUMENTS**

Pursuant to Article 4, paragraph (3) of the Law on the Agency for Identification Documents, Registers and Data Exchange of Bosnia and Herzegovina ("Official Gazette of BiH, No. 56/08), Article 28, paragraph (4) of the Law on Travel Documents of Citizens of Bosnia and Herzegovina ("Official Gazette of BiH, nos. 4/97, 1/99, 9/99, 27/00, 32/00, 19/01, 47/04, 53/07, 15/08, 33/08, 39/08 and 60/13) and Article 17 of the Law on the Council of Ministers of Bosnia and Herzegovina ("Official Gazette of BiH, nos. 30/03, 42/03, 81/06, 76/07, 81/07, 94/07 and 24/08), on the proposal of the Agency for Identification Documents, Registers and Data Exchange of Bosnia and Herzegovina, the Council of Ministers of Bosnia and Herzegovina on their 102nd session held on 25 June 2014, shall issue a

**RULLEBOOK
ON FEES
OF TRAVEL DOCUMENTS**

Article 1

This Rulebook shall regulate fees of travel documents, as follows:

a)	Passport	BAM 40
b)	Service passport	BAM 40
c)	Diplomatic passport	BAM 40
d)	Collective passport	BAM 50
e)	Seaman's passport	BAM 50
f)	Maritime booklet	BAM 50
g)	Travelling certificate	BAM 10
h)	Travel documents for refugees	BAM 40
i)	Travel documents for stateless person	BAM 40
j)	Travelling certificate for aliens	BAM 10

Article 2

(Disposal of Funds)

Funds collected by issuance of travel documents shall be paid to the specific account of the Ministry of Finances and Treasury of Bosnia and Herzegovina.

Article 3

(Provisional freeing of fee charges)

In the municipalities which competent entity authorities and the authorities of Brcko District declared as areas threatened by floods/landfalls, holders of the travel documents, who reported damage or loss of such documents and for whom the competent authorities, subject to their procedures, have

established that damage or loss occurred due to floods/landfalls, shall be freed of fee charges for the replacement of travel documents, of which the competent authority shall issue a Decision, while data concerning the issued Decision and the fact that a person is freed of charges shall be entered into the register.

Article 4
(Duration of provisional freeing of fee charges)

Provisional freeing of fee charges for personal documents referred to in Article 3 of the Rulebook shall last for 45 as of the day of entry into force of this Rulebook.”

Article 5
(Superseding)

This Rulebook shall supersede the Rulebook on fee of travel document (Official Gazette of BiH, no. 80/09) as of the day of its entry into force.

Article 6
(Entry into force)

This Rulebook shall enter into force on the eighth day following the day of its publication in the “Official Gazette of BiH”.
