

Pursuant to Article 8 paragraph (2) item f) and paragraph (3) item i) of the Law on Agency for Identification Documents, Registers and Data Exchange of Bosnia and Herzegovina ("Official Gazette of BiH", No. 56/08) and Article 17 of the Law on Council of Ministers of Bosnia and Herzegovina ("Official Gazette of BiH", nos. 30/03, 42/03, 81/06, 76/07, 81/07, 94/07 and 24/08), with regard to Articles 3 and 4 of the Rulebook on Travel Documents for Refugees ("Official Gazette of BiH, No. 80/09) and Article 2 of the Rulebook on design and content of the request for issuance of a travel document for refugees, travel document for stateless persons and travel document for aliens ("Official Gazette of BiH, No. 78/09), with the consent of the Ministry of Security of Bosnia and Herzegovina, the Council of Ministers of Bosnia and Herzegovina, at the 44th session held on 3rd April 2013, issued

D E C I S I O N

ON ASSIGNING AGENCY FOR IDENTIFICATION DOCUMENTS, REGISTERS AND DATA EXCHANGE OF BOSNIA AND HERZEGOVINA FOR PERSONALIZATION, TECHNICAL PROCESSING AND MAINTAINING REGISTERS OF TRAVEL DOCUMENTS FOR REFUGEES

Article 1 (Subject)

With this Decision the Agency for Identification Documents, Registers and Data Exchange of Bosnia and Herzegovina (hereinafter: Agency) is responsible for personalization and technical processing of travel documents for refugees, as well as for maintaining registers of travel documents for refugees.

Article 2 (Assignment of competent authority for personalization)

All applications for the issuance of travel documents for refugees submitted by the Ministry of Security of Bosnia and Herzegovina (hereinafter: Ministry) shall be personalized by the Agency, and after the personalization the document shall be returned to the Ministry, with the adequate status, which shall be submitted to the system that is within the competencies of the Ministry, and in accordance with the defined laws and by-laws.

Article 3 (Assignment of competent or source authority)

(1) The submitted data shall be processed, in accordance with the provisions of the Law on Movement and Stay of Aliens and Asylum ("Official Gazette of BiH", nos. 36/08 and 87/12), within the Ministry and submitted to the Agency through web services that the Ministry shall integrate in its system according to the technical rules defined by the Agency, in line with the Rulebook on the manner of access to registers and data exchange ("Official Gazette of BiH", No.35/09).

(2) The Ministry is, in accordance with the Law on Agency for Identification Documents, Registers and Data Exchange of Bosnia and Herzegovina ("Official Gazette of BiH", No.56/08), in order to realize personalization and technical processing of data of travel documents for refugees and maintain registers of travel documents for refugees by the Agency, obliged to perform biometric data acquisition in a manner envisaged by the Guidelines on the manner of biometric data acquisition ("Official Gazette of BiH", No.45/09) through its system (especially biometric data: fingerprints, photography, signature) in accordance with ICAO 9303 standards and provisions of the Rulebook on travel document for refugees ("Official Gazette of BiH", No. 80/09).

Article 4
(Implementation of the Decision)

The Agency and the Ministry are obliged for the implementation of this Decision.

Article 5
(Entry into force)

This Decision shall enter into force on the eight day of its publication in the "Official Gazette of BiH".
