Pursuant to Article 12 paragraph (5) of the Law on Travel Documents of Bosnia and Herzegovina (Official Gazette of BiH ", Nos. 4/97, 1/99, 9/99, 27/00, 32/00, 19/01, 47/04, 53/07, 15/08 , 33/08 and 39/08), the Ministry of Civil Affairs of Bosnia and Herzegovina issues a

**RULEBOOK
ON DESIGN AND CONTENTS OF
THE TRAVELLING CERTIFICATE**

Article 1
(Subject)

This Rulebook shall specify a design and contents of the travelling certificate.

Article 2
(Design)

- (1) A travelling certificate form shall be in the format 29.5 x 19 cm.
- (2) The form of the travelling certificate shall be printed one-sided on 120 grams glossy paper.
- (3) Emblem of Bosnia and Herzegovina shall be color printed.
- (4) Serial number of the travelling certificate shall be printed in blue, equal as the emblem of Bosnia and Herzegovina.
- (5) All other text contents of the travelling certificate shall be printed in black.
- (6) Security features are the type of paper and graphic design.

Article 3
(Contents)

- (1) Data on a person to whom the travelling certificate is to be issued shall be entered in person.
- (2) A photograph of a person to whom the travelling certificate is to be issued shall be labeled in the specified space.
- (3) Information concerning the family members of a person to whom a travelling certificate is to be issued, if they travel with him/her and label their photographs in the specified space, shall be entered into travelling certificate.

(4) Information concerning travelling certificate issuing authority as well as date of issue and validity period shall to be entered in the travelling certificate.

(5) Travelling certificate must be signed by the authorized person and verified by the stamp of the travelling certificate issuing authority.

Article 4
(Purpose)

(1) Travelling certificate shall be issued to a citizen of Bosnia and Herzegovina, who, anyhow, has lost his/her travel document for the purpose of return to Bosnia and Herzegovina.

(2) Travelling certificate has a single use.

Article 5
(Appendix)

An integral part of this Regulation is a graphical presentation of the design and contents of the travelling certificate.

Article 6
(Entry into force)

This Regulation shall enter into force on the day of its publication in the "Official Gazette of BiH".
